1) All Series conducted under the rules and regulations of the Ohio State Racing Commission, the United States Trotting Association and Northfield Park. 2) Post positions in all legs drawn by lot. 3) At the time of declaration, with the exception of championship legs, a horse must meet current qualifying standards at Northfield Park (official track variances allowed). 4) Declarations close at 9 a.m. in accordance with the current draw schedule at Northfield Park. 5) Nomination fee must accompany all nominations. No starting fees are required. 6) Northfield requires six separate betting interests in any event or it may be canceled. 7) In the event more than eleven enter any preliminary leg, the race will be split into divisions. (Maximum of ten horses per race if two or more divisions). 8) Nominating fees will be used toward the final purse. 9) Horses with the highest earnings in preliminary legs will qualify to compete in the final. The final will be limited to nine starters with no more than two declarations from any owner or any trainer. In the event that any of the highest money winners fail to declare, series starters (or entrants in a preliminary leg that does not fill) may be drawn by lot, if declared, to fill. 10) Northfield reserves the right to reject any entry and return fee, declare off the event if sufficient nominations (at least 10) are not received, and place any horse entered incorrectly into its proper class. 11) Stall space for all nominees may be revoked at any time. 12) Purse earnings in claiming series will be paid to the owner at time of declaration. In the event a horse is claimed during the series, all purse earnings accrued by a horse will count towards that horse's total for the final, regardless of the owner of the horse in a given leg. 13) In every horse's first start in a series, (regardless of what leg that start occurs), it will carry a claiming tag of the advertised base claiming price for the series (plus Allowances). 14) In a horse's second start in the series, (again, regardless of what leg it occurs), it will carry a claiming tag that is one level higher from their opening start. 15) If the horse starts in all three legs of the series, it will carry highest level claiming tag in the 3rd leg. 16) There is no claiming in the series finals, with the exception of horses that were scratched from a claimer in their previous start.
