

OFFICIAL \$10,000 GIVEAWAY RULES

Northfield Park will be awarding a \$10,000 Cash Prize on Saturday, July 3, 2010. Nine (9) finalists will be selected by various methods, described below. Each finalist will receive a horse number by random drawing. The finalist holding the official winning horse number in a race selected by Northfield Park will win the Grand Prize. In the event of a scratch(es) after the numbers have been assigned, entrant(s) holding that number(s) will be awarded a consolation prize. In the event of a Dead Heat for the winning position, Grand Prize will be divided equally between finalists holding the winning dead heat numbers.

FINALIST SELECTION

1. Three (3) Instant Finalist mystery tickets will be sent as part of our normal Mystery Ticket Promotion mailing. If ticket(s) are redeemed between 6 PM and 10 PM on Saturday, July 3, 2010, person holding that ticket will become one (1) of nine (9) finalists. In the event that all three (3) mystery tote tickets are not redeemed by 10 PM (EST) on Saturday, July 3, 2010, daily entry forms will be used for a random drawing to fill the balance of nine (9) finalists.
2. Four (4) finalists will be drawn from daily entry forms.
